This Adoption Contract (hereinafter "The Contract") is made on the date listed above by and between Tails of the Free Rescue (hereinafter "Tails of the Free") and Adopter (hereinafter the "Adopter"), residing at the address listed above. Tails of the Free hereby delivers to the Adopter and the Adopter hereby takes as an indoor pet, the pet listed above. The parties hereby agree to the following:

**1. HUMANE CARE OF PET**

Adopter is adopting pet as a companion animal. Pet will be kept inside, given fresh food, shelter, exercise and care as needed. Pet will be supervised when outside and will not be allowed to free roam. Adopter agrees not to abuse pet in any way including but not limited to animal fighting, testing, experimentation, or any other unusual treatment.

Adopter agrees not to surgically alter pet unless deemed medically necessary. This includes declawing and any cosmetic alterations such as ear cropping and tail docking. If the pet is lost or stolen Adopter will make a reasonable effort to recover pet.

**2. PET'S HEALTH AND HISTORY**

Tails of the Free makes no representation to the health, temperament, mental or physical disposition of the pet. Tails of the Free will make their best effort to convey any and all information about the pet as possible. Unless otherwise stated, all animals receive the "core" tests and vaccines. Cats and kittens are tested, and are negative for Fiv/FeLV and receive at least: one FVRCP (3-1 Vaccine), Revolution flea treatment and worming. Dogs are tested for Heartworm and receive at least: one distemper shot, revolution and worming. All animals get rabies if old enough and all animals are spayed and neutered. Other tests, vaccines, medicates and treatments are done on an as needed bases under the guidance of a vet.

**2. POST ADOPTION**

Adopter will give the Pet a reasonable amount of time to adjust to their new environment and will inform Tails of the Free if they are unable to continue caring for Pet. Tails of the Free does not guarantee to take the Pet back, but will work with Adopter to ensure the safety of the Pet. Adopter agrees not to sell, trade, barter or surrender pet without notifying Tails of the Free. Adopter agrees to permit Tails of the Free, to complete a home check to verify the health and well-being of the Pet and agrees that if Pet is abused, neglected or the terms of this contract are otherwise violated Adopter agrees to return the Pet to Tails of the Free upon their demand.

**3. RELEASE OF LIABILITY**

All adoptions are final and adopter should handle any questions and / or reservations prior to the completion of the adoption. Adopter is adopting at Adopter's own risk and indemnifies and releases Tails of the Free, its founder(s), and volunteers from any and all liability arising from damages to person(s) or property caused by the Pet. Adopter agrees Tails of the Free is not responsible for any costs relating to the Pet once adopted. Adopter understands that Tails of the Free makes no guarantees and/or promises regarding the Pet's disposition, temperament, and/or health and personality.
